Arriving late will result in your exam being canceled. Once you arrive, you will be asked to show a valid, government-issued photo ID. If your ID is invalid or you forget to bring it, you will not be permitted to sit for the exam.Once the check-in process is complete, you will be asked to leave all personal items (cell phone, books, papers, notes, food, jacket, hat, etc.) in a secure locker outside the testing room.Once the exam begins, you are permitted to take breaks, but the timer will not be stopped while you are away.Remote TestingOn the day before your exam, you should check your computer's audio, video, and webcam to ensure everything is working as expected. You will need to download and install an application that will perform a system check to ensure your laptop or desktop operating system meets the minimum requirements.On the day of the exam, you will need to clear your testing area of your cell phone, reference materials, scratch paper, and food or drink containers. You will be asked to show your ID and to scan your testing area with your webcam.You can launch the examination up to 30 minutes before your scheduled appointment. You cannot leave the webcam's view during your exam, use other monitors, or talk to anyone. It's good to check along the way to see whether your studying is paying off. One of the most effective ways to do this is by taking SIE practice tests to evaluate your progress. Practice tests are useful because they show exactly where you need to improve. Every time you take a free SIE exam practice test, pay special attention to these three groups of questions:The questions you got wrongThe ones you had to guess on, even if you guessed rightThe ones you found difficult or slow to work throughThis will show you exactly what your weak areas are and where you need to devote more study time. Ask yourself why each of these questions gave you trouble. Was it because you didn't understand the material? Was it because you didn't remember the vocabulary? Do you need more repetitions on this type of question to build speed and confidence?
