How long is a spouse open work permit valid? Individuals who have applied to be sponsored by their spouse, or those whose spouses are in Canada on a study or work permit may be able to apply for a spousal open work permit. Note: Immigration policies and fees are subject to change. If requested, you may need to provide a detailed relationship history explaining how and when you met, your engagement or wedding, and your time spent together. Ineligibility at Port of Entry: You cannot apply for a SOWP at a port of entry. Residence: To be eligible for SOWP, you must be physically residing in Canada with your spouse or common-law partner during the application process. Joint financial responsibilities (e.g., shared accounts or investments). Your sponsor must be: A Canadian citizen or permanent resident, or A foreign national authorized to work in Canada (e.g., on a valid work permit). Can a spouse open work permit be extended? There is no minimum amount of time that an applicant must wait before applying for a permit after getting married. Ensure you maintain legal status throughout the process, as applying without valid status can lead to delays or refusals. Open work permit holders must also comply with federal, provincial or territorial labour laws to work.
