Nona Dirksmeyer, a young beauty queen from Arkansas, is found dead in her apartment. Her boyfriend, who had returned from college, is charged with her murder. His family mortgages their home to fund his defense, but the case is not settled and a new trial ensues. The defense also raised doubts about Kevin Jones's guilt, suggesting he might be the actual perpetrator who had escaped justice. This argument led to a mistrial in the first trial. During the second trial, the court heard about Gary's previous conviction for assaulting a woman in 2002, but again, the evidence proved inconclusive. Ultimately, the jury was divided once more, resulting in another mistrial. Despite this, Gary Dunn has since been sentenced to prison for unrelated incidents, including kidnapping and indecent exposure, and is currently serving a 15-year sentence at the Arkansas Department of Correction-Wrightsville Unit.
